**AMENDMENT 3
CONTRACT NO. 4217**

THIS AMENDMENT TO CONTRACT 4217 (Contract), for lighting, emergency lighting, specialty equipment, public safety equipment, and accessories, parts, and installation services, is entered into and effective this January 1, 2025, by and between the City of Tallahassee (City), a Florida municipal corporation, and Williams Communications Inc. (Contractor), a Florida corporation with principal offices at 5046 Tennessee Capital Boulevard, Tallahassee, Florida, 32303, referred to herein individually as a "Party" or collectively as the "Parties."

RECITALS

WHEREAS, the Parties entered into the Contract on May 29, 2018, and have extended the Contract through May 28, 2026, copies of which are available in the City's Treasurer-Clerk's office and are incorporated herein by reference; and,

WHEREAS, Vendor Partners were identified in Contractor's awarded Proposal, dated October 27, 2017, through Request for Proposals No. 0106-17-KM-RC and incorporated into the Contract; and

WHEREAS, pursuant to Section 1.1.2 of the Contract, the Parties have agreed to amend the Contract to include a change order that adds Vendor Partners to provide goods and services from additional sources; and

WHEREAS, the Parties have agreed Section 3.0 of the Contract allows mutual extension of the initial Term for a total Term period of ten (10) years, and the Parties desire to renew the Contract through the final two (2) years available under the Contract.

NOW THEREFORE, in consideration of the mutual promises contained herein, and other good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, the Parties agree to the following:

1. The above recitals are hereby incorporated into, and made a part of, this Contract.
2. The Contract hereby includes goods and services from the following Vendor Partners at the discounted rates specified:

VENDOR PARTNERS	DISCOUNT
Whelen	27% off list price
Havis	21% off list price
Brother Pocketjet printers and accessories	15% off list price


3. The Contract is hereby extended through May 28, 2028.
4. Except as specifically amended herein, the terms and conditions of the Contract remain the same and shall continue in full force and effect.


